

STABLE RULES

IN ORDER TO MAINTAIN SAFETY TO ALL RIDERS AND HORSES, AS WELL AS MAINTAIN CLEANLINESS THROUGHOUT THE STABLE AND GROUNDS, GREEN TREE HORSE FARM HAS ESTABLISHED THE FOLLOWING RULES TO BE FOLLOWED.

ALL RIDING AND HANDLING IS DONE AT YOUR OWN RISK!

- 1. CIGARETTE, CIGAR AND PIPE SMOKING ARE PROHIBITED UNDER THE ROOFS OF THE BARNS. UPON ARRIVAL, PLEASE EXTINQUISH CIGARETTES.
- 2. WE RECOMMENED THAT HALTERS BE REMOVED FROM HORSES IN STALLS AND TURNOUT AREAS. IF HALTERS MUST BE LEFT ON, BREAKAWAYS WILL BE REQUIRED.
- 3. NO HORSE IS TO BE LEFT UNATTENDED TIED IN ITS STALL OR ON CROSSTIES.
- 4. ASTM/SEI HARD HATS ARE REQUIRED AT ALL TIMES WHEN RIDING. BOOTS OR RIDING SHOES WITH HEELS ARE REQUIRED AT ALL TIMES WHEN RIDING.
- 5. NO UNATTENDED CHILDREN ARE ALLOWED. CHILDREN ARE NOT ALLOWED (UNTIL THEY HAVE REACHED THEIR 13TH BIRTHDAY) AT THE BARN WITHOUT ADULT SUPERVISION.
- 6. CHILDREN ARE NOT ALLOWED (UNTIL THEY HAVE REACHED THEIR 13TH BIRTHDAY) TO HANDLE AND/OR RIDE ANY HORSE ON THE PREMISES UNLESS AN ADULT, WHO IS RESPONSIBLE AND SUPERVISES THE CHILD, COMES WITH THE CHILD ONTO THE PREMISES AND ACCOMPANIES THE CHILD AT ALL TIMES THE CHILD IS HANDLING AN/OR RIDING HORSES ON THE PREMISES.
- 7. THERE WILL BE NO RIDING IN THE BARNS AT ANY TIME.
- 8. DO NOT BLOCK DOORS AND ALLEYWAYS (EXCEPT WHEN YOUR HORSE IS IN CROSSTIES).
- 9. ALL OWNERS, RIDERS AND BLACKSMITHS/FARRIERS MUST CLEAN UP AFTER THEMSELVES. MANURE SHOULD BE DUMPED IN DESIGNATED AREAS ONLY.
- 10. LOCK THE TACK ROOM/OFFICE PRIOR TO LEAVING THE PROPERTY IF NO ONE ELSE IS AROUND. ANY LOSS OF EQUIPMENT IS NOT THE RESPONSIBILITY OF GREEN TREE HORSE FARMS, ITS MANAGEMENT OR EMPLOYEES.
- 11. ALL HORSES MUST BE WASHED IN DESIGNATED WASHING AREAS. WATER HOSES SHOULD BE RECOILED AND FAUCETS TURNED OFF TIGHTLY WHEN YOU ARE FINISHED WITH THEM.
- 12. IN AN EMERGENCY, A VET WILL BE CALLED AT YOUR EXPENSE IF YOU CANNOT BE REACHED OR IF YOU FAIL TO TAKE APPROPRIATE MEASURES.
- 13. PLEASE BE SURE TO HAVE ON FILE AT THE STABLE OFFICE. (1) SIGNED STABLE RULES. (2) SIGNED EQUINE ACTIVITY RELEASE AND HOLD HARMLESS AGREEMENT. (3) A SIGNED BOARDING AGREEMENT AND CURRENT NEGATIVE COGGINS AND RABIES CERTIFICATE IF YOUR HORSE IS KEPT HERE.
- 14. ANY UNNECESSARY REPRIMANDING OF ANY KIND TO A HORSE SUCH AS ABUSIVE SPURRING, GROSS NEGLECT, HARMFUL TRAINING METHODS, OR INJURY BY DRUG INTAKE WILL NOT BE TOLERATED BY THIS ESTABLISHMENT.
- 15. IF YOU CHOOSE TO BRING YOUR DOG ON THE PREMISES, GREEN TREE HORSE FARM REQUIRES YOU TO LEASH AND HAVE CONTROL OF YOUR DOG AT ALL TIMES.
- 16. IF YOU BRING FRIENDS OR RELATIVES, THEY WILL BE EXPECTED TO FOLLOW ALL THE RULES AND REGULATIONS APPLYING TO THIS FACILITY. FAILURE TO DO SO WILL RESULT IN THEM AND POSSIBLY YOU, BEING ASKED TO LEAVE.
- 17. BOARD AND RENT IS DUE THE 1ST OF THE MONTH AND IS LATE BY THE 5TH OF THE MONTH. THE LATE CHARGE FROM THE 6th − 15TH OF THE MONTH IS \$15, AFTER THE 15th is \$25. IF PAST DUE 60 DAYS, LEGAL ACTION WILL BE TAKEN TO HAVE YOU REMOVED FROM GREEN TREE HORSE FARM.
- 18. ANY CONCERNS AND REQUESTS MUST BE ADDRESSED IN WRITING WITH THE DATE AND YOUR NAME AND PLACED IN THE OFFICE IN THE BARN, OR EMAIL TO jessica@greentreehorsefarm.com.
- 19. BOARDERS ARE REQUIRED TO CHECK WITH MANAGEMENT BEFORE MAKING STALL OR TACK ROOM CHANGES AND BEFORE MOVING YOUR TRAILER FROM IT'S DESIGNATED PARKING SPOT.
- 20. ARENA AND TRAIL COURTESY SHOULD BE RECOGNIZED AT ALL TIMES. WHEN RIDING ON THE RAIL, PASS LEFT SHOULDER TO LEFT SHOULDER.
- 21. HELP YOUR FELLOW RIDERS AND BOARDERS. ALWAYS TRY TO WORK TOGETHER. INFIGHTING, GOSSIPING AND GENERAL POOR BEHAVIOR TOWARDS PEOPLE OR HORSES WILL NOT BE TOLERATED.
- 22. BE RESPECTFUL OF OTHER PEOPLE'S PROPERTY.
- 23. TURN OFF ALL LIGHTS WHEN LEAVING.

YOUR COOPERATION IN RECOGNIZING THE IMPORTANCE OF THESE RULES, AS WELL AS ADHERING TO THEM IS GREATLY APPRECIATED. THIS IS YOUR NOTICE OF THESE RULES. THE ABOVE RULES ARE SUBJECT TO CHANGE AT THE MANAGEMENT'S DISCRETION.
